Chronology:

A Product Safety and Compliance Committee (PSCC) investigation was opened on January 21, 2020 following a report of a right hand front seat assembly supplied to the Graz vehicle assembly plant had been built incorrectly.

The PSCC requested the Jaguar Land Rover Purchase department Supplier Technical Assistance (STA) team undertake a thorough investigation into Lear's Voderady plant manufacturing processes and controls.

On February 4, 2020 the PSCC was informed the Lear manufacturing process had been reviewed and deviations identified from the recognized and approved process. The error being that the control of fasteners in the serial product line changed but the controls were not translated into the rework areas where old level fastener identification was being used. This led to misidentification of the location of the not OK fasteners from serial production in the rework station, and the release of seats without correction being completed. Lear was requested to identify all seat frames where the escape point occurred. Lear also confirmed the required controls to ensure no further escapes had been implemented, this was verified by the Jaguar Land Rover STA function.

The investigation concluded the issue should be progressed to the Jaguar Land Rover Recall Determination Committee (RDC).

The RDC reviewed all information on February 6, 2020 and the committee determined the condition represented an unreasonable risk to safety to the occupants of the vehicle and a safety recall shall be conducted.

There have been no reported accidents, injuries or fires as a result of this concern.
