Description of the Defect: Affected vehicles had their Heating, Ventilating and Air Conditioning (HVAC)

blower motor replaced from October 9, 2019 through November 22, 2019 as part of recall 19V-726 (19S34). The replacement part that was installed may have been built with an improper clearance between an electrical terminal and the conductive base plate slot that may result in a resistive electrical short.

Description of the Safety Risk: A blower motor built with improper clearance between the electrical terminal

and the conductive base plate may result in a resistive electrical short that

can increase the risk of overheating, melting, smoke and/or fire.

Description of the Cause: The blower motor supplier did not properly quarantine suspect motors that were built with an improper clearance between an electrical terminal and the conductive base plate slot. These suspect motors were shipped to Ford's service distribution network.

#### **Description of Remedy:**

Description of Remedy Program: Owners of vehicles repaired under FSA 19S34 from October 9, 2019 (FSA approval date) through November 22, 2019 (19S34 Dealer Bulletin Supplement #3) will be notified by mail and instructed to take their vehicle to a Ford or Lincoln dealer to have the HVAC blower motor date code inspected. Motors built within the suspect timeframe will be replaced. There will be no charge for this service.

> Ford is excluding reimbursement for costs because the original warranty program would provide for a free repair for this concern.

Ford will forward a copy of the notification letters to dealers to the agency when available.

How Remedy Component Differs Suspect service blower motors were built with part number KB3Z-19805from Recalled Component: AC and a build date code of 190614 (June 14, 2019) through 190922 (September 22, 2019). Blower motors with a date code outside of these are not affected by this concern. The remedy components were produced after the quality concern was identified and corrective actions were implemented.
