February 2020, DTNA reviewed warranty to investigate potential additional reports in the field. 5 warranty claims were shared with Meritor. The 5 claims reported, are within the expanded population recommended by Meritor in NHTSA equipment recall 20E-006. March 17, 2020, based on Meritor's notification of its NHTSA 573 filing and a review of warranty claims, DTNA has decided to recall the additional suspect vehicles identified by Meritor.
