and GMC Savana vehicles may fail to conform to S7.3 of Federal Motor Vehicle Safety Standard (FMVSS) 208, Occupant crash protection. In these vehicles, the seatbelt-unfastened telltale will not illuminate for approximately five seconds after the ignition is moved to the on or start position. There is no impact to the vehicle's seat belt systems, and the telltale will function normally after the five

second delay.

FMVSS 1: 208 - Occupant crash protection

Description of the Safety Risk: During the five-second delay, the telltale will not alert the driver that the

driver's seatbelt is unbuckled, however, there is no delay in the activation of

seat belt warning chimes.

Description of the Cause: Transtech Bus built certain 2020 model year bodies on chassis affected with a

software change implemented for 2019 model year Chevrolet Express and GMC Savana vehicles contains an error that inhibits the activation of the telltale

for five seconds after vehicle startup.

On September 26,2019 TransTech Bus notified by GM Fleet Commercial product Division of a noncompliance Recall N192264500-01-- Seat belt Reminder Telltale Delay. Transtech Bus proceeded to have any vehicles in our inventory scheduled to have the software reprogramming performed by our NYS local Chevy Dealer. On October 21,2019 Transtech Bus received and forwarded VIA UPS Recall notification notices from General motors to all TransTech Bus Dealers.

On March 11, 2020 TransTech Bus received a request from NHTSA on performing a voluntary recall notification on behalf of GM.
