#### **Description of Defect :**

Description of the Defect :	Mercedes-Benz AG ("MBAG"), the manufacturer of Mercedes-Benz vehicles, has determined that on certain Model Year ("MY") 2020 E-Class (C238 platform) vehicles, the front left seatbelt might not have been installed according to current production specifications.
FMVSS 1 :	NR

Description of the Safety Risk :	If the seatbelt is improperly installed, the seatbelt could contact sharp-edged sheet metal components, and could damage the seatbelt webbing in the event the emergency tensioning restraint system is activated. Damage to the seatbelt webbing could impair the restraining effect of the seatbelt, increasing the risk of injury for the occupant in the front left seat.
Description of the Cause :	Due to a production deviation, on certain vehicles the seatbelt on the front left seat of certain vehicles might not have been mounted according to specification.

#### **Chronology**:

In September 2019, MBAG launched an initial investigation into findings from regular internal vehicle inspections that the front left seatbelt did not completely retract into the seatbelt housing. It was found that the seatbelt on this particular vehicle was not installed according to current production specification. Review of the production process found that a new temporary worker had not followed appropriate procedures during the initial shifts. The worker was re-trained and all affected vehicles were marked for check and rework in the plant prior to shipment. In March 2020, MBAG conducted a review of open plant actions. This review indicated that the seatbelts in certain vehicles might not have been checked as intended during the rework process. MBAG evaluated the potential consequences if the seatbelt were not mounted according to specification, and found the potential for the seat belt webbing to contact surrounding sheet metal parts located at the loudspeaker and found that the webbing could be damaged in the event of restraint system activation. On April 14, 2020, MBAG decided to conduct a recall to address the affected vehicles.

#### **Description of Remedy :**

Description of Remedy Program :	An authorized Mercedes-Benz dealer will check the seatbelt routing on the front left seat on the affected vehicles and correct it, if necessary. If the webbing is damaged, the seatbelt assembly will be replaced. Pursuant to 49 C.F.R. § 577.11(e), MBUSA does not plan to provide notice about prenotice reimbursement to owners since none of the involved vehicles would have been previously subject to the condition described and all remain
	covered under the new vehicle warranty.
