On April 14, 2019 GILLIG was formally notified by Agility about equipment recall# 20E-019 filed by Agility with NHTSA, related to the subject defect and affecting a limited population of GILLIG buses. On April 15 GILLIG started its own investigation to confirm population affected. On April 29 GILLIG submitted its own defect reports to NHTSA to recall the corresponding vehicle population equipped with the PRD systems affected by the defect described in 20E-019.

Description of Remedy :

Description of Remedy Program :	Agility intends to work with GILLIG to arrange owner notifications and replacement of the potentially defective PRDs on affected vehicles. Since all of the subject products remain under the manufacturer's warranty, Agility has requested an exemption from the reimbursement plan requirements pursuant to 49 CFR 577.11(e).
	The defective PRDs (Part Numbers PRD2302T-004, PRD2322T-001, and PRD2322T-004) will be replaced with PRDs that meet specifications.
	Starting from $3/3/2020$ all uncompleted vehicles have been retained at GILLIG and corrected before being shipped out.
