Description of Defect:

Description of the Defect: Mercedes-Benz AG ("MBAG"), the manufacturer of Mercedes-Benz vehicles, has

determined that on certain Model Year ("MY") 2020 GLB-Class vehicles (247 platform), the vehicle body might not be sealed in the area of the front wheel

wells according to current production specifications.

Description of the Safety Risk: Under certain conditions, it is possible for water to enter from the wheel

wells into the front occupant foot wells. This might impair the functionality of the control units and other electrical components installed in these areas. For

example, the instrument cluster might malfunction and not show any

information. Furthermore, the engine might stall during driving or might not start, increasing the risk of a crash. a consequence, the risk of a crash would

be increased.

Description of the Cause: Due to a deviation in the production process, the vehicle body might not have

been sealed according to current production specifications on certain vehicles.

Chronology:

At the end of November 2019, MBAG launched initial investigations based on a finding during a regular quality inspection of a new vehicle regarding potential water intrusion into the front foot wells.

Between December 2019 and March 2020, MBAG received reports from multiple countries that appeared potentially related to water intrusion in the front foot wells. These vehicles were analyzed as well regarding the root cause. MBAG determined that an incorrectly applied seam seal in the area of the front wheel wells was the cause for the water intrusion.

In parallel, potential effects to vehicle functions and components were investigated and the range of potentially affected vehicles analyzed.

On April 24, 2020, MBAG determined that a potential safety risk cannot be ruled out.

Description of Remedy:

Description of Remedy Program: An authorized Mercedes-Benz dealer will seal the vehicle body in the

subject area and check the front foot wells for water intrusion. In the event

that water intrusion is confirmed, the necessary repair will be carried out.

Pursuant to 49 C.F.R. § 577.11(e), MBUSA does not plan to provide notice about pre-notice reimbursement to owners since none of the involved vehicles would have been previously subject to the condition described

and all remain covered under the new vehicle warranty.
