#### **Description of Defect:**

Description of the Defect: Mercedes-Benz AG ("MBAG"), the manufacturer of Mercedes-Benz vehicles, has

determined that on certain Model Year ("MY") 2019-2020 G-Class vehicles (463 platform) the embossed lock symbol for the child safety lock operating lever on the rear doors might indicate the incorrect locking status of the child

safety lock.

FMVSS 1: NR FMVSS 2: NR

Description of the Safety Risk: In this case, the incorrectly embossed symbol could lead to a

misinterpretation of the locking status of the child safety lock. As a result, the rear doors could be opened from the inside despite the indication of a locked door. Conversely the rear doors could not be opened from the inside despite the symbol indicating that the rear door is unlocked. This could increase the

risk of injury to the occupants in the second seat row.

In the operator's manual, the operating direction of the child safety lock is

stated and described correctly.

Description of the Cause: Due to a deviation in the development process, an incorrect lock symbol might

have been embossed in the rear doors of certain vehicles.

#### **Chronology:**

In the end of 2019, MBAG After-Sales became aware of a potential issue on the G-Class regarding the child safety lock symbol on the rear doors.

Investigations regarding the root cause and potential consequences were started.

It was found that all regulatory requirements were met and that the operator's manual clearly describes the operating direction of the child safety lock. In addition a review of field data was performed. This review did not show any customer complaints regarding the child safety lock. Although the embossed symbol was only intended to indicate the function of the child safety lock lever it cannot be completely ruled out, that the incorrectly embossed information symbol might lead to misinterpretation of the rear doors' locking status of the child safety lock.

In parallel, the range of the potential affected vehicles was determined.

On April 24, 2020, MBAG decided to conduct a recall to address this issue in the field out of an abundance of caution.

#### **Description of Remedy:**

Description of Remedy Program: An authorized Mercedes-Benz dealer will install a label on the rear doors

with the correct child safety lock status.

Pursuant to 49 C.F.R. § 577.11(e), MBUSA does not plan to provide notice about pre-notice reimbursement to owners since none of the involved vehicles would have been previously subject to the condition described
