# **Chronology:**

Received and email through the Thor port about National sales having U-bolt failures on their spare tire carrier. This issue was looked at on 1/14/20 and there were no claims in the system for this issue. National has had two other manufacturers reach out about having issues with the bolts. National made the decision to recall all carrier made from 10/15/2019 - 2/4/2020. I sent an email to the safety committee informing them of the scope of units that we will have affected and adding a voting button so they can respond with yes/no to vote on recalling this issue once National has filed with NHTSA. Email was sent on 2/17/2020. Safety committee voted yes to issue a recall. We were instructed to wait to file our recall until National Sales had issued the recall and informed us of their filing. Heartland RV was never notified about National Sales issuing the recall and due to the Covid pandemic our offices were closed and employees were furloughed from the end of March until 5/11/2020. After returning to the office we noticed that we had not heard anything from National sales and proceeded with filing our recall for the tire carrier.
