| Description of Remedy Program :                                     | The dealers and owners will be directed via a recall letter to inspect the specific recall population in their fleet. Freedman has created a video instruction that will be used to do this, If defective seat belt retractors are found Freedman will replace them. Freedman will reimburse the cost of repairs including parts and labor. The reimbursement will be \$25 per belt. After inspections are completed a form must be sent in to Freedman Seating for quarterly reporting purposes. The quarterly reporting for this recall will be completed by Freedman Seating since they are collecting the inspection/repair forms from the dealers and end users. |
