The rear axle GAWR is correct. During 06/17/2020 through 6/22/2020 The manufacturing plant investigated by reviewing production records, along with the Federal Placards and were able to determine that since inception of this model, all Placards are affected.

On 6/26/2020 Forest River's Corporate Recall Committee voted to recall.
