#### **Description of Noncompliance :**

	The dinette seatbelts may be too small and not fit up to a 95th percentile male, which is a non-compliance of FMVSS 208 & 209.
FMVSS 1 :	209 - Seat belt assemblies
FMVSS 2 :	208 - Occupant crash protection
Description of the Safety Risk :	If a person is unable to properly buckle themselves while the motorhome is in motion, in the event of a crash there is an increased risk of serious injury and death.
Description of the Cause :	The wrong length seatbelts were installed in the motorhome.
	If a male in the 95th percentile were to sit in the dinette booth of the motorhome, they would not be able to properly fasten the seatbelt.

#### **Chronology**:

7/8/2020 When doing a test of the dinette seatbelts in a finished unit in Production, Engineering found that they were unable to buckle themselves as they fit into the 95th percentile for males. Engineering determined that the 146" belt they ordered from the vendor was indeed a 120" belt that was being installed into the units. 7/14 to 7/15/2020 Customer service met with Engineering for a visual inspection and repair of an affected unit. A scope of potential affected units was determined.

7/17/2020 The TMC Safety Committee met and determined that recall will need to be released due to this non-

Description of Remedy Program :	TMC will instruct dealers on how to replace the 18" tether with a 24" tether on both side of the dinette booth. Reimbursement will be provided through the normal warranty claim process.
How Remedy Component Differs from Recalled Component :	The remedy component will have the 24" tether.
	Any units after the 6/25/2020 offline date that already had the seatbelt installed received the replacement tether. Any units still in production will have the correct seatbelt installed.
