Description of the The subject vehicles are equipped with Smart Cruise Control (SCC). One of Noncompliance: SCC's functions is to independently apply the brakes to decelerate the vehicle when the system senses a vehicle in front of it within the set distance. When a trailer is connected to the subject vehicles, the trailer brake lights do not illuminate when the SCC independently brakes to decelerate the vehicle. As such, these vehicles fail to comply with the requirements of Federal Motor Vehicle Safety Standard (FMVSS) 108, "Lamps, Reflective Devices and Associated. The vehicle's brake lights are not affected by this condition.

FMVSS 1: 108 - Lamps, reflective devices, and assoc. Equipment

FMVSS 2: NR

Description of the Safety Risk: Failure to notify other vehicles of the driver's intent increases the risk of a

crash.

Description of the Cause: No signal from the vehicle to the trailer to illuminate the trailer brakes is sent

when the SCC independently brakes to decelerate the vehicle.
