7/24/2020 During a ship row audit by TMC's Engineering Dept., it was discovered that production had substituted the barrel seat pedestal bolts with 3/8" bolts instead of the required ½" bolts. 7/28/2020 Notice of audit was provided to Recalls Dept. Scope of units potentially affected by this issue was compiled.

7/31/2020 TMC Safety Committee met and in an abundance of caution, determined a recall will be needed to correct the non-compliance.
