Chronology :

On or about March 2020 we had a customer with a failure. We immediately contacted Dexter Axle to examine the axle and they found that they could potentially have a manufacturing defect with serial number 133158559. Due to the safety concerns and what a potential failure could do they felt best that we do a recall on any trailer we produced during this time that required a D52 model axle.

Description of Remedy :

Description of Remedy Program : We will need the customer to take trailer into local dealership to have the axle inspected. We are allowing .5 hours per trailer for the inspection. If they find that the axle is serial number 133158559 the axle is considered suspect and will need to be replaced and new one will be sent to dealer to install. They will be allowed .5 hour rack-time per unit VIN and .8 hour per axle to be replaced.

How Remedy Component Differs from Recalled Component : The axle serial number is what will distinguish this.

Identify How/When Recall Condition was Corrected in Production : Dexter only shipped us so many axles at this time that could be suspect. Therefore anything with this serial number stamped on it is suspect and was only made during a short period by Dexter Axle.

Description of Recall Schedule : Letters were drafted and will be sent out first to the dealers and then secondly to the retail customers based off their warranty registrations. Dealer notifications will be sent out by August 20, 2020 and retail customer notifications will be sent out by August 25, 2020.
