On October 13/2020 it was noted that an incorrect brass connector was being used in the propane connection to the flared connection of the Truma water heater. The Vendor indicated that brass connector was incorrect for the application that it was being used for.

Description of Remedy:

Description of Remedy Program: Dealers with Inventory will be sent an SOP (Standard Operating

Procedure) and the correct brass connector (Part #115-3219) to replace the incorrect brass connector. Dealers will submit a warranty claim for reimbursement. Retail Owners will be provided the SOP & the correct brass connector. They will be advised to contact their selling dealer or an RV Service center to have the connector installed. The Retail Owner will be reimbursed or the Servicing center will be paid directly by Triple E RV. A Retail Owner or Servicing center will be reimbursed for costs incurred

for repair prior to the recall notification.

How Remedy Component Differs The correct brass connector has the same threading but the thickness of

Identify How/When Recall Condition On October 13/2020 the correct brass fitting was ordered and installation was Corrected in Production: took place in the production process. For units that had the incorrect

fitting installed during the manufacturing process an in-house campaign

was performed to replace with the correct fitting.

Design dept. updated the propane drawings and the bill of materials was

changed to reflect the new part & part #115-3219.
