On 12/1/2020 Upon searching safercar.gov we found that an amended 573 with remedy was available. On 12/1/2020 Forest River filed a pass through recall.

From this point onwards, in series production the EC screwdriver was replaced by using an electric torque wrench in combination with a

second hand check.
