Description of the Defect : On certain vehicles, the sewer termination bracket may fail causing the plumbing to become detached from the bracket.

FMVSS 1 : NR

FMVSS 2 : NR

Description of the Safety Risk : If the plumbing were to become detached from the bracket, this could cause the sewer termination plumbing to drag on the ground or become completely detached from the vehicle causing a crash, property damage and/or injury.

Description of the Cause : On certain vehicles, the securement of the bracket was insufficient to hold the length of the sewer termination plumbing in place.

9/21/2020 – Received VOQ 11354675 indicating a problem with the sewer pipe.

9/24/2020 – OCC opened an investigation to review plant installation and securement processes and inspection of units.

11/11/2020 – Processes, inspections and analysis completed.

11/13/2020 – Recall Committee met and requested further analysis of data due to no clear trend of year and make.

12/4/2020 – Investigation and scope complete. Corporate Recall Committee voted to recall.

12/30/2020 – Upon reviewing the scope of vehicles affected OCC inadvertently missed adding one specific floor plan. This floor plan accounts for 10 additional VINs adding to US population. 2018 RPOD. Total vehicles affected in the US is now 2,828

Description of Remedy :

Description of Remedy Program : Forest River will provide all parts and labor free of charge to consumer to add securement to the sewer termination pipe. An authorized Forest River Dealer or Service Center will need to perform the repair.

Forest River intends on pushing the mailing out as soon as NHTSA provides any correction(s) and an Acknowledgement Letter.
