IMPORTANT SAFETY RECALL

Vee Tyre and Rubber Co., Ltd., Campaign: 6MSLD8 2117 and 2217

Dear Customer/Distributor/Owner:

This Notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Vee Tyre and Rubber Co., Ltd., has decided that certain model Taiga A/T tires size LT285/75R16 pneumatic tires manufactured in Thailand during the 21st and 22nd weeks of 2017, failed to conform to Federal Motor Vehicle Safety Standard (FMVSS) 49 CFR 571.139. Vee Tyre and Rubber Co., Ltd. is recalling 522 of these tires in the United States.

The tires can be identified by the DOT numbers molded into the sidewall of the tires. The DOT numbers will range from 6MSL D8 2117 to 6MSL D8 2217.

WHAT PROBLEMS MAY ARISE FROM THE TIRE?

Sidewall separation may result, leading to tire failure, increasing the risk of a motor vehicle crash.

WHAT WILL VEE TYRE AND RUBBER CO., LTD. DO?

Vee Tyre and Rubber Co., Ltd. will replace the recalled tires at NO CHARGE and waive the service fee or reimburse the customer for the cost of the tires. Vee Tyre and Rubber Co., Ltd will review receipts, repairs and other documentation submitted by affected owners or users; contact one of 3 U.S. dealers of the affected tires if necessary; arrange for refund or reimbursement and/or replacement of the affected tire(s) as may be appropriate.

WHAT SHOULD YOU DO?

Contact Vee Tyre and Rubber Co., Ltd. For your free repair as soon as possible. Collect and/or save receipts and/or auto repair bills for reimbursement consideration.
