If the steering column casing cover is not installed, small hardware could enter the steering column area. Additionally, it is possible that small objects (e.g. cable ties ends) from the production and assembly process could enter the steering column area. If any such small objects were to enter the subject space, it is possible that steering operation could be affected, thereby increasing the risk of a crash. An authorized Mercedes-Benz Sprinter dealer will replace the steering column with the intended variant that includes the cover.

Prior to performing this Recall Campaign:

- Please check VMI to determine if the vehicle is involved in the Campaign and if it has been previously repaired.
- Please review the entire Recall Campaign bulletin and follow the repair procedure exactly as described.


