Keystone RV Company has decided that a defect which relates to motor vehicle safety exists in certain model 2018-2020 Hampton Travel Trailers. As a result, Keystone RV is conducting a safety recall.

***Reason for
this recall***

It has been decided that the vehicles fail to conform to the requirements of Part 567, "Certification." The vehicles subject to this recall may have been manufactured with the incorrect information on the Federal Identification Tag. The tag indicates the tire pressure as 6 PSI. The correct tire pressure is 80 PSI. An incorrect label may lead to unintentionally underinflating the tires, increasing the risk of a crash. The vehicles included in the recall are:
