Work Instructions

Subject: FCCC Motorhome Chassis Rear PDMs

Models Affected: Specific Model Year 2016-2020 Freightliner Custom Chassis X-Line chassis manufactured November 23, 2015, through June 3, 2019, and equipped with a certain PDM.

PDM Inspection and Replacement

- 1. Check the base label (Form WAR259) for a completion sticker for FL856 (Form WAR260) indicating this work has been completed. The base label is usually located on the front wall under the dash. If a sticker is present, no further work is needed. If there is no sticker, proceed with the next step.
- 2. Park the vehicle on a level surface, shut down the engine, and set the parking brake. Chock the tires.

NOTE: If necessary, call FCCC for assistance on location of the PDM. FCCC CAC (800) 206-3519

- 3. Locate the serial number on the side of the PDM. If the serial number is equal to, or less than, 18106398, go to the next step. If serial number is greater than 18106398, go to step 10.
- 4. Disconnect the chassis battery ground cable from the battery.

NOTE: Not all of the PDM electrical connections will be used.




Fig. 1, PDM Components

5. Disconnect all electrical connections to the PDM. See Fig. 1.

6. Remove the mounting fasteners attaching the PDM to the chassis and remove the PDM.

IMPORTANT: When replacing the PDM, remove the cover from the new PDM and compare the fuse and relay configurations with the PDM being replaced. Body builders may have added optional fuses and relays after the chassis was built. If this is the case, make certain to remove and reinstall the additional fuses and relays in the same location on the new PDM and replace the cover.

- 7. Using the mounting fasteners removed earlier, attach the PDM to the chassis.
- 8. Connect all electrical connections to the PDM.
- 9. Connect the chassis battery ground cable to the battery.
- 10. Clean a spot on the base label (Form WAR259). Write the recall number, FL856, on a blank red completion sticker (Form WAR260), and attach it to the base label to indicate this recall has been completed.
