The fuel rail bolts on affected vehicles may become loose over time. This can result in a fuel leak. Leaking fuel, in the presence of an ignition source, may result in a vehicle fire.

**Precautions** 

If this condition is present in the vehicle, owners may notice a fuel odor or see leaking fuel coming from the engine compartment. Owners experiencing this condition with their vehicle are advised to contact an authorized Volkswagen dealer without delay to make arrangements to have the vehicle inspected/repaired.

Repair:

- REPAIR AVAILABLE February 23, 2021 / Replace the affected fuel rail bolts and, if necessary, replace the fuel rail.
- See ELSA/ServiceNet for complete repair & claiming instructions
- Check both the daily Campaign Open Inventory report <u>and</u> OMD for affected vehicles in inventory. Verify OPEN status in ELSA <u>on the day of repair</u>.
- Repair every affected inventory vehicle <u>before delivery to consumers</u>.

**Parts Allocation:** 

Dealers will be sent an initial, targeted allocation prior to customer notification.

<u>New Vehicles in Dealer Inventory:</u> It is a violation of federal law for a dealer to deliver a new motor vehicle or any new or used item of motor vehicle equipment (including a tire) covered by this notification under a sale or lease until the defect or noncompliance is remedied. By law, dealers must correct, prior to delivery for sale or lease, any vehicle that fails to comply with an
