On December 10, 2020, American Honda notified NHTSA of a stop sale and safety recall for certain 2018-2020 Accord and 2019-2020 Insight vehicles for communication failures in the body control module. These failures may cause various warning lights to turn on and render various vehicle features inoperable, causing the vehicle to be noncompliant with Federal Motor Vehicle Safety Standards (FMVSS).

To ensure proper repairs, American Honda stopped the sales of all pre counter-measured 2018-2020 Accord and 2019-2020 Insight Body Control Modules (BCM). Effective immediately all dealers that have inventory of the below parts are asked to stop installing and return parts back to American Honda.
