## **IMPORTANT SAFETY RECALL**

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Compañía Hulera Tornel, S.A. de C.V., ("Tornel") has decided that a defect which relates to motor vehicle safety exists in certain passenger car radial tires. Tornel has initiated a voluntary recall of these tires. These tires were sold in the replacement market beginning in May 2019. They were manufactured during DOT week of 2216, and the DOT weeks of 4116 through 5016.

You are receiving this letter because Tornel records indicate that you have purchased tires that may be the subject of this safety recall.

In affected tires, there may be a risk of tread block separation between the belt and tread, which may lead to partial chunking of tread blocks. This detached tread block can cause loss of performance. If this warning is not heeded, a vehicle crash can occur.



The DOT Tire Identification Number can be found on the tire's sidewall immediately following the symbol "DOT". Below is an example of a typical DOT Tire Identification Number as provided by NHTSA.



## TIRE REPLACEMENT PROGRAM

Tornel will replace any tire subject to the recall with new tires, and mount the replacement tires, all at no charge to you. If you own tires that match the exact description of the Brand, Tire Line, Tire Size, and the DOT Tire Identification Number listed above, contact the tire retailer who sold you these recalled tires to arrange verification and replacement at no charge through December 31, 2020. To locate an authorized Tornel dealer near you, please call 1-281 919 1944.

Any tire that is the subject of this recall will be replaced with a comparable Tornel P235/60R14, tire manufactured outside of the affected production range. If a Tornel brand tire is not currently available, a suitable competitive product may be used as a replacement tire.

## REIMBURSEMENT TO CUSTOMERS FOR AFFECTED TIRES PRIOR TO RECALL

If you purchased tires subject to this recall and have already paid for a replacement due to the condition associated with this recall, you may be eligible to receive reimbursement. Requests for reimbursement may include parts, labor, fees and taxes. Reimbursements may be limited to the amount the replacement would have cost if completed by an authorized Tornel dealer. To be eligible for reimbursement, you must present records documenting the following information to Tornel:

- The name and address of the person or company that paid for replacement.
- The brand name, tire line name, size and DOT Tire Identification Numbers (including date codes) of the replaced tire(s).
- A description of the problem that occurred with the replaced tire(s).

- The total cost paid to replace the tire(s) that is being claimed.
- Proof of payment (copy of front and back of cancelled check or copy of credit card receipt)
