A safety defect exists in your vehicle

- Schedule an appointment with your authorized Freightliner Sprinter dealer as soon as possible.
- This repair will be provided free of charge.

Dear Freightliner Sprinter Owner or Lessee,

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Mercedes-Benz AG ("MBAG"), the manufacturer of Freightliner Sprinter vans, has decided that a defect which relates to motor vehicle safety exists in certain Model Year 2019 Freightliner Sprinter vehicles. Our records indicate that your vehicle is included in the affected population of vehicles.

What is the CONCERN?

MBAG determined that on certain Freightliner Sprinter vehicles, the information label indicating the maximum speed was not affixed to the spare wheel. Without the label, an operator could operate the vehicle in excess of the spare wheel's maximum speed, increasing the risk of a crash.

What will your DEALER DO? An authorized Freightliner Sprinter dealer will attach the speed limitation label on the spare wheel. <u>This service will be provided free of charge</u>. While the minimum repair time is **approximately 30 minutes**, your dealer can provide you with a better estimate of the overall time for this service visit. As a matter of normal service process, an authorized Freightliner dealer will also check for other repair measures which might be applicable to your vehicle and this may increase the required working time. You will not be charged for other service or repairs unless so requested.

Schedule an appointment immediately at your preferred authorized Freightliner Sprinter Dealer. Please mention you are scheduling an appointment to attach the speed limitation label on the spare wheel under Recall Campaign # 2020040013. You may be asked for your 17-digit Vehicle Identification Number (VIN) which for your convenience is located above your name at the top of this letter.

In the event that you are no longer the vehicle owner, or have had a change of address, please complete the reverse side and return the updated information in the enclosed envelope.
