# IMPORTANT SAFETY RECALL

## **Rear Visibility Default View**

Dear [Name],

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

FCA US has decided that certain [2019 Model Year (LD) Dodge Charger] Pursuit (Police) vehicles fail to conform to Federal Motor Vehicle Safety Standard (FMVSS) No. 111 – Rear Visibility.

It is extremely important to take steps now to repair your vehicle to ensure the safety of you and your passengers.

#### WHY DOES MY VEHICLE NEED REPAIRS?

The Body Control Module (BCM) software on your vehicle [1] may not meet FMVSS No. 111 which requires that the rear visibility system default to the rearview image being visible, at the beginning of each backing event, regardless of any modifications to the field of view that the driver had previously selected. Suspect vehicles are equipped with a "stealth mode" that disables the rearview image when selected and the system does not default to displaying the rearview image at the beginning of the next backing event after being engaged. The vehicle operator will notice that the rearview image is not displayed if attempting to reference the image while backing. If this warning is not heeded, backing without verifying it is safe to do so, could lead to an increased risk of injury to people outside the vehicle.

### HOW DO I RESOLVE THIS IMPORTANT SAFETY ISSUE?

FCA US will repair your vehicle <sup>[2]</sup> free of charge (parts and labor). To do this, your dealer will inspect and if necessary, update body control module software to disable stealth mode when the vehicle is shifted into REVERSE. The estimated repair time is about 30 minutes. In addition, your dealer will require your vehicle for proper check-in, preparation, and check-out during your visit, which may require more time. Your time is important to us, so we recommend that you **schedule a service appointment for November 5**<sup>th</sup> or later to minimize your inconvenience. Please bring this letter with you to your dealership.
