### Subject: Freightliner Cascadia Brake Light Illumination

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Daimler Truck North America LLC (DTNA), on behalf of its Freightliner Trucks Division, has decided that a defect which relates to motor vehicle safety exists on specific Model Year 2017-2021 Freightliner Cascadia vehicles manufactured March 8, 2016, through January 3, 2020, and equipped with a certain pressure switch.

On certain vehicles, the brake lights may remain on after release of the brake pedal, which may prevent accurate communication to following vehicles, potentially leading to an increased risk of a crash.

The 3-pin brake pressure switch will be replaced with a 2-pin brake pressure switch and jumper harness. A software update is also required. Repairs will be performed by Daimler Trucks North America authorized service facilities.

This is the second notice regarding this recall. The final recall repair is now available and parts have been secured. Please contact an authorized Daimler Truck North America dealer to arrange to have the Recall performed and to ensure that parts are available at the dealership. The Recall will take approximately two hours and will be performed at no charge to you. You may be liable for any progressive damage that results from your failure to complete the Recall within a reasonable time after receiving notification.

If you do not own the vehicle that corresponds to the identification number(s) which appears on the Recall Notification, please return the notification to the Warranty Campaigns Department with any information you can furnish that will assist us in locating the present owner. If you have leased this vehicle, Federal law requires that you forward this notice to the lessee within 10 days. If you are a subsequent stage manufacturer, Federal law requires that you forward this notice to your distributors and retail outlets within five working days. If you have paid to have this recall condition corrected prior to this notice, you may be eligible to receive reimbursement. Please see the reverse side of this notice for details.

### Reimbursement to Customers for Repairs Performed Prior to Recall

- The total cost of the repair expense that is being claimed.
- Proof of payment for the repair (such as the front and back of a cancelled check or a credit card receipt).
