

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Ferrari has determined that a defect which relates to motor vehicle safety might exist in certain Model Year 2018-2020 812 Superfast vehicles. The vehicles involved are potentially equipped with an incorrectly bonded rear window, which may lead to decreased long-term adhesion of the rear window. As a result, the rear window could fully detach from the vehicle. We want to assure you that your safety is our priority, and we are committed to correcting this condition in your vehicle.

While waiting for the recall to be performed, you may drive your car while respecting the posted speed limits. We urge that you do not drive your car on a track or closed circuit until this repair is completed,

Our records show that you are the owner of a vehicle affected by this recall.

<u>IMPORTANT – CONTACT YOUR DEALER TODAY</u>

Ferrari will repair your vehicle for free. The repair involves replacing the rear window. The replacement part is now available, please contact your Ferrari dealer and make an appointment to have this free repair performed. The time needed for this repair is estimated between 2 and 3 hours plus the time for the glue to cure (approximately 4 more hours).

If you have any questions or concerns that your dealer is unable to resolve, please contact Ferrari North America, Inc. at +1(201) 816-2668. If your Dealer or Ferrari is unable to remedy the defect without charge or within a reasonable amount of time, you may submit a complaint to the Administrator, National Highway Traffic Safety Administration, 1200 New Jersey Ave., S.E., Washington, DC 20590, call the toll-free Vehicle Safety Hotline at 1-888-327-4236 (TTY: 1-800-424-9153), or go to NHTSA.gov.

If you have previously paid for repair to your vehicle for this specific condition prior to receiving this letter, send your original receipts and/or other adequate proof of payment to the following address for reimbursement: Ferrari North America, Inc., 250 Sylvan Ave., Englewood Cliffs, NJ 07632 Attention: Warranty Department. Once we receive and verify the required documents, reimbursement will be sent to you within 60 days.

For vehicles registered in California: The California Department of Motor Vehicles, in conjunction with California Air Resources Board, requires the completion of emission recall repairs prior to vehicle registration renewal, per the Registration Renewal/Recall Tie-in Program. Your authorized Ferrari dealer will provide you with a Proof of Correction Certificate after the recall repair has been performed.
