## CONDITION SUMMARY:

#### **SITUATION:**

An issue has been identified on certain Land Rover vehicles within the listed Affected Vehicle Range where the Tire Pressure Monitoring System pressure has not been set correctly in the Instrument Panel Cluster. The set Instrument Panel Cluster stored pressures are used by the Tire Pressure Monitoring System to determine pressure thresholds against which Tire Pressure Monitoring System warning system activation should occur. The Tire Pressure Monitoring System will not illuminate the warning telltale at the correct pressure when the tire pressure is 25% below the manufacturer's recommended cold inflation pressure as stated on the Tire Placard. The Tire Pressure Monitoring System set pressure on the Instrument Panel Cluster does not correspond with the correct information on the Tire Placard.

Vehicles in this condition will not meet the requirements of Federal Motor Vehicle Safety Standards (FMVSS) 138 Tire Pressure Monitoring System.

Operating a vehicle with tires at low inflation pressures can contribute to separation of the tire tread. If the tread separates from the tire, the driver can lose control of the vehicle, possibly resulting in a crash.

#### **ACTION:**

Retailers are required to HOLD affected new vehicles that are within your control and refrain from releasing the vehicles for new vehicle sale pending completion of the procedure(s) detailed in this Technical Bulletin. Unsold vehicles should have this performed as part of the Pre-Delivery Inspection (PDI) process but must have it completed prior to vehicle handover to the customer.

Affected vehicles already in the hands of customers should be updated at the next available opportunity.

#### WARRANTY INFORMATION:

## NOTE:

Use the Jaguar Land Rover claims submission system to make sure that a vehicle is eligible for this program prior to undertaking any rework action.

At the time of confirming a booking for vehicle repair, make sure that all open Recall and Service Actions are identified to make sure the correct parts are available and adequate workshop time is allocated for repairs to be completed at one visit. Warranty claims must be submitted quoting the Program Code and the relevant Option Code; this will result in payment of the stated time. The SRO and parts information is included for information only. The Option Code(s) that allows for the drive in/drive out allowance may only be claimed if the vehicle is brought back into the workshop for this action alone to be undertaken.

Repair procedures are under constant review and therefore times/prices are subject to change; those quoted here must be taken as guidance only. Use TOPIx to obtain the latest repair time.

Warranty claims must be submitted or payment within 30 calendar days of completion of the repair.

DIAGNOSTIC INSTRUCTION:

# **CAUTION:**

All ignition ON/OFF requests MUST be performed; failure to do so may cause damage to vehicle control modules.

CAUTION:

A Jaguar Land Rover-approved battery support unit must be connected to the vehicle startup battery during diagnosis / module programming.

Connect the Jaguar Land Rover-approved battery support unit to the vehicle startup battery.

NOTE:

The Jaguar Land Rover-approved diagnostic equipment must be loaded with PATHFINDER version 297 (or later).

Connect the Jaguar Land Rover-approved diagnostic equipment to the vehicle and begin a new session.

- 3. Follow all on-screen instructions.
  - 1 Select 'ECU Diagnostics'.
  - 2. Select 'Tire Pressure Monitor Module [TPM]'.
  - 3. Select 'Update ECU'.
  - 4. Follow the on-screen instructions until the application finishes successfully.

- 4. **Only if required:** set the vehicle to Transit mode.
  - 1. Follow the on-screen instructions until the application finishes successfully.
- 5. Exit the current session.
- 6. Disconnect the diagnostic equipment and battery support unit from the vehicle.
