Yukon Egress Window Crank


Keystone is conducting a voluntary RECALL notification campaign in accordance with the National Highway Transportation and Safety Act. It has been decided that the vehicles in the recall population have an egress window installed in the bedroom and did not have the correct crank handle installed. If an emergency situation arises the emergency exit may be difficult to open as the current black round knob may impede the ability to open the window, which could result in an increased risk of personal injury.

The remedy is to replace the black round knob on the bedroom egress window with the narrow crank handle.

REPAIR INSTRUCTIONS

Step 1

Locate the trailer on a level, flat, hard surface. Chock the wheels.

Step 2 Locate the bedroom egress window. Figure 1

Step 3

Remove the black round knob and install the narrow crank handle using KRV # 114843 - Crank Handle - Red - Full Exit Window and KRV # 532131 - Screw - #8-32 x 1" RMHS - For Window Crank Handle - FR01108-1 (Canadian Dealers purchase locally). See Figure 2.

Step 4

Proceed to warranty reimbursement.
