## ! IMPORTANT SAFETY RECALL !

### CHECK AND (IF NECESSARY) RE-ROUTE IGNITION SWITCH WIRING

Safety Recall: SRAN574  
NHTSA Recall: 20V150

**This notice applies to your motorcycle:**

**Model:** 2013 – 2017 Trophy SE A1 and Trophy SE A1 Launch.

**VIN:** SMTXXXXXX

Dear [NAME]:

This is a follow up notification regarding NHTSA recall 20V150 for your motorcycle with the details mentioned above. As of August 22, 2022 our records indicate that the recall remedy for this motorcycle has not been completed. Using your 17-digit VIN, you can go to <https://www.triumphmotorcycles.com/owners/recalls> to check for all open recalls and also to locate your closest Triumph dealer. Please contact your local Triumph dealer to arrange for this important safety work to be carried out on your motorcycle without further delay.

Details concerning this recall, which can also be found in the initial recall notification letter we sent you, are as follows:

**The reason for this recall notice:** On your motorcycle, the ignition switch wiring may be at risk of being damaged by the front brake hose. If this condition occurs and remains undetected, it may lead to a loss of electrical power to various electrical circuits. As a consequence, the headlight may malfunction or the engine could stall, increasing the risk of a crash.

**What Triumph Motorcycles Ltd & your dealer will do:** Triumph Motorcycles Ltd has authorized your dealer to check and if necessary re-route the ignition switch wires free of charge to you including parts and labor. This repair should take less than 30 minutes. However, depending upon the dealer's work schedule, it may be necessary to make your motorcycle available for a longer period of time.

**What you must do to ensure your safety:** Please make an appointment with your authorized Triumph motorcycles dealer to have this important remedy performed on your motorcycle as soon as possible.

**Federal regulations require that any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within 10 days.**

**If you need help:** Please contact your authorized Triumph dealer should you have any questions or encounter any difficulty regarding this recall. In the event your dealer is unable to remedy your motorcycle, please contact Triumph Motorcycles America at 1-678-854-2010.

If you previously paid to have this recall performed on your motorcycle, you may be eligible for reimbursement. Please contact Triumph Motorcycles at 1-888-284-6288 for more information, including eligibility requirements.
