**Subject:** Loose Foam in Child Seat May Become Choking Hazard

This letter serves to acknowledge Clek, Inc.'s notification to the National Highway Traffic Safety Administration (NHTSA) of a safety recall which will be conducted pursuant to Federal law for the product(s) listed below. **Problem Description:**

Clek, Inc. (Clek) is recalling certain Foanf, model numbers FO12 through FO19, and Fllo, model numbers FL15 through FL19, convertible child seats manufactured prior to May 21, 2021. A child may pick pieces of foam from the foam cushion located under the seat pad.

**Consequence:**

Loose pieces of foam can present a choking hazard to a child, increasing the risk of injury.

**Remedy:**

Clek will provide a molded plastic insert that prevents access to the foam, along with instructions on how to attach it to the child seat, free of charge. Owner notification letters are expected to be mailed in December 2021. Owners may contact Clek customer service at 1-866-656-2462.

We have received Clek's proposed owner notification letter and envelope and they are currently under review. You will be notified of any changes or concerns once our review is complete.



Please be reminded of the following requirements:

Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

Please be reminded that under 49 U.S.C. § 30112(a)(3), it is illegal for a manufacturer, to sell, offer for sale, import, or introduce or deliver into interstate commerce, a motor vehicle or item of motor vehicle equipment that contains a safety defect once the manufacturer has notified NHTSA about that safety defect. This prohibition does not apply once the motor vehicle or motor vehicle equipment has been remedied according to the manufacturer's instructions.

As stated in Part 573.7, submission of the first of eight consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
