Problem Description:

Vermeer Manufacturing Company (Vermeer) is recalling certain 2015-2021 AX19 brush chipper trailers. A crack may develop in the undercarriage frame and cause the frame to bend.

Consequence:

A bent frame may cause a loss of control, increasing the risk of a crash.

Remedy:

The remedy is still under development. Owner notification letters are expected to be mailed June 17, 2021. Owners may contact Vermeer customer service at 1-800-829-0051 ext. 7060. Vermeer's number for this recall is IK4078.

As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
