This letter serves to acknowledge HME, Inc.'s notification to the National Highway Traffic Safety Administration (NHTSA) of a safety recall which will be conducted pursuant to Federal law for the product(s) listed below. ### **Problem Description:**

HME, Inc. (HME) is recalling certain 2018 Ram 5500 emergency vehicles. The flanged wheel lug nuts may have been overtightened during service.

### **Consequence:**

An over-tightened lug nut may cause the wheel stud to break, resulting in wheel separation and increasing the risk of a crash.

# Remedy:

No remedy has been established at this time. The manufacturer has not yet provided a schedule for recall notification. Owners may contact HME's customer service at 1-616-534-1463.

Also, copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).



As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
