ENGINE AND ENGINE COOLING: ENGINE: OIL/LUBRICATION: PIPES, HOSES, AND FITTINGS

**Potential Number of Units Affected:** 1

### **Problem Description:**

Lamborghini (Automobili Lamborghini) is recalling one 2021 Aventador SVJ Roadster vehicle. The heat exchanger oil line screws may have been improperly tightened during assembly, which could cause the oil lines to detach.

### **Consequence:**

Detached oil lines may leak oil onto hot components, increasing the risk of a fire.

# Remedy:

A dealer will inspect and repair the heat exchanger oil line connections as necessary, free of charge. The owner notification letter is expected to be mailed December 3, 2021. Owners may contact Automobili Lamborghini customer service at 1-866-681-6276. Automobili Lamborghini number for this recall is L73X-R.02.21.

Please be reminded of the following requirements:

Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

Please be reminded that under 49 U.S.C. § 30112(a)(3), it is illegal for a manufacturer, to sell, offer for sale, import, or introduce or deliver into interstate commerce, a motor vehicle or item of motor vehicle equipment that contains a safety defect once the manufacturer has notified NHTSA about that safety defect. This prohibition does not apply once the motor vehicle or motor vehicle equipment has been remedied according to the manufacturer's instructions.

As stated in Part 573.7, submission of the first of eight consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
