Description of the Defect: To perform their function, certain electronic controllers on the vehicle may

send datalink TSC1 messages requesting the engine to limit engine speed or torque. These electronic controllers, if the vehicle is so equipped, may perform safety-related functions, such as vehicle braking control, vehicle traction control, vehicle stability control, vehicle speed control, or vehicle collision avoidance or other functions. Due to a software calibration error in the subject calibration options, the subject engines may not limit engine speed or torque when such a device requests the limit via J1939 datalink TSC1 messages.

December 10, 2020 – An OEM reported to Cummins Westport that an engine was not properly responding to a J1939 TSC1 message during testing with adaptive cruise control at the OEM.

December 11-16, 2020 - Cummins Westport investigated and confirmed the report.

December 11, 2020 – January 27, 2021 – Cummins Westport determined root cause and developed and released a calibration to correct the issue.

January 22 – February 9, 2021 – Cummins Westport and Cummins evaluated the potential safety implications of the issue and reviewed the issue with the Cummins Product Safety Defect Board.

February 10, 2021 - The Cummins Westport Board of Directors decided to conduct a safety campaign. To date,

there have been no reports of accidents or injuries due to this condition.

Description of Remedy:

Description of Remedy Program: Cummins Westport and Cummins will conduct a safety campaign to

recalibrate the Engine Control Module with a corrected calibration.

Pursuant to 49 CFR 577.11(e), Cummins Westport requests that it be exempt from providing notification of a reimbursement plan. Any prenotification product failure would have been replaced under the

manufacturer's limited warranty. Accordingly, no person would be eligible

for reimbursement pursuant to 573.13.
