Description of the Defect : Onemore auto part INC. is recalling certain aftermarket headlight bulbs, in configurations TX002/9005FBA,TX002/9006FBA,TX001/H7FBA,EX-PLA9012FBA,TX001/9004FBA,TX001/9004FBA,TX001/9007FBA,TX002/H4FBA ,TX002/H13FBA only sold through Amazon.com.Those replaceable light source's maximum luminous flux was above the maximum limit during the first ten minutes, then falls within legal limits; there are dimensional requirements that were not met in that there are no resistive filaments, and does not conform with marking requirements.

FMVSS 1 : 108 - Lamps, reflective devices, and assoc. Equipment

FMVSS 2 : NR

Description of the Safety Risk : The maximum luminous flux was above the maximum limit, and may cause excessive brightness for the first ten minutes of use. At this time, there are no known instances of crashes or injuries caused by excessive brightness by use of this bulb

Description of the Cause : Excessive glare may result because luminous flux output exceed the luminous flux limitations of FMVSS 108. The equipment may, in certain applications, create excessive glare or brightness for oncoming drivers. There are currently no known instances of crash caused by glare or brightness from the bulbs being recalled.

Identification of Any Warning that can Occur : These bulbs will not be used as headlight bulbs.

The equipment does not meet certain dimensional standards for replaceable light sources set by Standard No. 108, exceeds the luminous flux standards for replaceable light sources established by Standard No. 108, and is devoid of certain markings.

Description of Remedy :

Description of Remedy Program : One more auto parts inc. will notify customers to change back to halogen, instructing them to return the bulbs for a full refund, To qualify for such replacement, a claimant must fill out a recall request form and provide proof of purchase, and agree to return the recalled bulb.
