Description of Noncompliance :

1	The Yorkim R7 H11 LED bulbs (ASIN: B07TVM56DK) for replaceable headlamp light do not meet the filament dimensional standard set by FMVSS 108, exceed the luminous flux standard for replaceable light sources set by FMVSS 108, and do not have the manufacturer name/logo or the symbol "DOT" as required by FMVSS 108.
FMVSS 1 :	108 - Lamps, reflective devices, and assoc. Equipment
FMVSS 2 :	NR
Description of the Safety Risk :	The Yorkim R7 H11 LED bulbs (ASIN: B07TVM56DK) for replaceable headlamp light may, in certain applications, create excessive glare or brightness for oncoming drivers. There are currently no reported incidents or safety complaints from any consumer.
Description of the Cause :	1. LED bulbs do not have a filament like the tungsten bulbs that result in failure to meet filament requirements of FMVSS 108 standard, and the bulbs exceeded the dimension requirement specified in FMVSS 108 standard.

2. The luminous flux output of the Yorkim R7 H11 LED bulbs (ASIN: B07TVM56DK) for replaceable headlamp light exceeds the luminous flux limitations of FMVSS 108.
3. The Yorkim R7 H11 LED bulbs (ASIN: B07TVM56DK) for replaceable headlamp light do not have the manufacturer name/logo or the symbol "DOT" as required by FMVSS 108.

Yorkim received an email from the National Highway Traffic Safety Administration's Office of Vehicle Safety Compliance informed Yorkim that the Yorkim R7 H11 LED bulbs (ASIN: B07TVM56DK) for replaceable headlamp light are noncompliant to the Federal Motor Vehicle Safety Standard No. 108 "Lamps, reflective devices, and associated equipment," according to the results of FY 2021 compliance test program.

Description of Remedy Program :	Yorkim will post a recall notification for the Yorkim R7 H11 LED bulbs (ASIN: B07TVM56DK) for replaceable headlamp light on the product detail page on the Amazon store and its website. Yorkim will provide a full refund to customers who have purchased the Yorkim R7 H11 (ASIN: B07TVM56DK) replaceable headlamp light source on Yorkim's Amazon store. Yorkim will not offer replacement because Yorkim discontinued the sale of the Yorkim R7 H11 (ASIN: B07TVM56DK) replaceable headlamp light sources on the Amazon store in February 2021, which is earlier than Yorkim had received NHTSA's notification.

0	Yorkim discontinued the sale of the Yorkim R7 H11 (ASIN: B07TVM56DK) replaceable headlamp light source in February 2021. Yorkim will not sell the Yorkim R7 H11 (ASIN: B07TVM56DK) replaceable headlamp light sources anymore until they are certified to FMVSS 108.
