Descriptive Information: ZF makes this submission at NHTSA's request based on the recall of vehicles by

Spartan Fire, LLC (21V252), Autocar, LLC (21V677), Shyft Group (21V752), Sutphen (21V891), Mack Trucks, Inc. (21V856) Volvo Trucks North America (21V858), and Oshkosh (21V851) that incorporate certain ZF power steering pumps that may have been subject to an issue in the rotor grinding process during manufacturing. ZF has not determined that the manufacturing issue presents an unreasonable safety risk for all potentially affected power steering pumps in each vehicle application. ZF's understanding is that the purchasers identified herein other than Spartan Fire, Autocar, Shyft Group, Sutphen, Mack Trucks, Volvo Trucks North America, and Oshkosh have concluded investigating or continue to investigate any effect presented by the potentially affected power steering pumps in their vehicles.

The total number of potentially affected parts specified herein is the number of parts ZF supplied to the recalling vehicle manufacturers that were manufactured within the identified suspect production dates. The relevant ZF part numbers are PS362815R10311, PS362815R10511, PS362816R10511 (supplied to Spartan Fire); PS322416L10300, PS322816L10200, PS362816L10300,

PS362816R10500 (supplied to Autocar); and PS322418R10511 (supplied to

Shyft Group).

The information provided herein is based on information available to ZF at the time of submission and may not include all information available to the vehicle manufacturers.

Description of Defect:

Description of the Defect: As reported by Spartan Fire, Autocar, Shyft Group, Sutphen, Mack Trucks, Volvo

Trucks North America, and Oshkosh, certain power steering pumps supplied by ZF may cause pressure to build and the shaft seal to leak into the engine, resulting in a loss of power steering assist in the identified recalled vehicles. ZF's understanding is that its power steering pumps operate under conditions specific to each vehicle application. ZF is not aware of any accidents or injuries

related to the recalls announced by Spartan Fire, Autocar, Shyft Group,

Sutphen, Mack Trucks, Volvo Trucks North America, or Oshkosh related to the

subject power steering pumps in other manufacturers' vehicles.

Description of the Safety Risk: As reported by Spartan Fire, Autocar, Shyft Group, Sutphen, Mack Trucks,

Volvo Trucks North America, and Oshkosh, a loss of power steering assist in

the recalled vehicles could increase the risk of a crash.

Description of the Cause: The rotor grinding process may have created an area of localized flatness in the

end face of the steering pump motor during manufacturing of the power steering pumps. Depending upon the vehicle application (due to applicationspecific operating conditions), the localized flatness may cause pressure to

build and the shaft seal to leak into the engine.

Chronology:

In July 2020, Spartan Fire notified ZF about a zero mileage issue identified in Spartan Fire's assembly plant involving power steering pumps supplied by ZF. ZF thereafter conducted a technical analysis of affected parts, verified production parameters, performed calibrations, and verified potential corrective measures through lab measurements and testing, resulting in an identified manufacturing issue. In September 2020, ZF implemented containment measures with inspections put in place. ZF continued to monitor warranty data but did not detect an issue with other vehicle manufacturers similar to what was experienced by Spartan Fire. In October 2020, ZF implemented a grinding change in its manufacturing process to address the issue. In April 2021, Spartan Fire informed ZF of a warranty claim involving loss of power steering assist. On April 10, 2021, Spartan Fire initiated a recall of 243 vehicles containing power steering pumps supplied by ZF (21V252). In July 2021, ZF responded to an informal inquiry by NHTSA's Recall Management Division related to the Spartan Fire recall. On August 4, 2021, at the agency's request, and although ZF had not made a safety defect determination with respect to the subject power steering pumps, ZF submitted a list of purchasers to NHTSA with a Part 512 request for confidential treatment. On August 31, 2021, Autocar initiated a recall related to vehicles containing power steering pumps supplied by ZF (21V677). On September 3, 2021, NHTSA requested that ZF file a part 573 report based on the Spartan Fire and Autocar recalls. Although ZF has not determined that a safety-related defect exists in the subject power steering pumps, ZF agreed to submit a Part 573 report as requested. To date, ZF has not received any reports of accidents or injuries related to the recalled vehicles or the vehicles of other manufacturers in which the subject power steering pumps are installed.

ZF refers to the vehicle manufacturers' respective Part 573 Defect Information Reports for recall notification schedules, which include the estimated dates of their respective owner, distributor and dealer notifications. ZF is not aware of any other dealers

or distributors affected by these recalls.
