Descriptive Information :	This recall covers an optional accessory driver all-weather floor liner designed and intended for use in 2017 – 2021 model year Chevrolet Bolt vehicles. The affected floor liners were identified through vehicle manufacturing data and part sales data. Other floor mats and liners for this vehicle population and 2022 model year vehicles use different designs and are not included in this recall. GM's part-sales data contains an associated VIN for 3,078 sales of the recalled accessory liner. An additional 811 floor liner sales are not associated with a specific VIN in GM's records.

### **Description of Defect :**

Description of the Defect :	General Motors has decided that a defect, which relates to motor vehicle safety, exists in certain front driver all-weather floor liners sold as an optional accessory for 2017 – 2021 model year Chevrolet Bolt EV vehicles. In certain vehicles, the driver may be able to push a properly secured liner forward until it can contact or entrap the accelerator pedal when the accelerator pedal is fully depressed.

Description of the Safety Risk :	If the liner contacts and entraps the accelerator pedal while driving, it can cause unintended acceleration, increasing the risk of a crash. If this occurs,
	the driver can apply the vehicle's service brake, which will engage the vehicle's brake-override system and stop the vehicle. GM is advising owners to remove the recalled floor liner until a replacement is available.
Description of the Cause :	Grommet movement caused by the construction of the vehicle's carpet can create insufficient clearance between the mat and the pedal in some vehicles.
Identification of Any Warning that can Occur :	The driver may notice contact between the liner and the accelerator pedal.

#### **Chronology** :

On July 28, 2021, a GM analyst submitted an issue to GM's Speak Up For Safety program based on an observed increase in NHTSA VOQs alleging unintended acceleration in Chevrolet Bolt EV vehicles. GM's investigation identified 15 field claims (claim dates range from August 2020 through July 2021) that contain allegations consistent with accessory floor-liner interference to the accelerator pedal. GM's design review and analysis of part-sales data indicates that these allegations are specific to an accessory floor liner offered for sale in 2017-21 model year Chevrolet Bolt EV vehicles.

GM is not aware of any crashes or injuries associated with this condition. On October 7, 2021, GM's Safety and Field Action Decision Authority decided to conduct an equipment safety recall.

#### **Description of Remedy :**

Description of Remedy Program :	Dealers will replace the accessory floor liner. Pursuant to 577.11, GM will provide reimbursement to owners for repairs according to the plan submitted on May 12, 2021.
	Replacement accessory floor liners have additional clearance to the accelerator pedal to avoid potential interference.
Identify How/When Recall Condition was Corrected in Production :	The accessory all-weather floor liner was redesigned for the 2022 model year.
