The sidewall bulges result from either production variations which could result in excess thickness of the bead filler, or a stacked ply ending condition due to ply width specifications. Both issues can result in trapped air voids in the sidewall during manufacturing and can cause sidewall bulges in-use under certain use conditions. Both were eliminated through improvements to tire production processes or tire ply width specifications on or before December 1, 2019.

#### **Chronology**:

The review that led to this recall was initiated in response to a customer complaint of a sidewall bulge developing on the white sidewall, as well as conditions observed in tires cut as part of the quality surveillance process. Cooper Tire initiated a review and through testing determined the tires were built on a uni-stage machine and included design features that under certain circumstances could lead to sidewall bulges developing in the white sidewall of the tire. A monitoring of the return rates for these tires over time revealed rates trending above Cooper Tire's overall return rates for this condition. Cooper Tire reviewed all FMVSS testing and the products met government standards.

On February 12, 2021, the Compliance Committee determined that a potential safety condition exists in the subject tire. Cooper Tire is voluntarily recalling 430,298 of these tires. There have been no property damage

or death or injury claims associated with any of these tires related to this issue.

# **Description of Remedy :**

Description of Remedy Program :	Cooper Tire & Rubber Company (Cooper Tire) will initiate a voluntary safety recall of the subject tires. Cooper Tire will contact registered owners that purchased tires of the specified date range by registered mail. Customer correspondence will explain the issue, and include instructions on how to obtain replacement tires, as well as instructions for collecting reimbursement for remedies made prior to recall. The tires with affected identification numbers should be returned to one of Cooper Tire & Rubber Company's Regional Inspection Points, where they will be inspected for the affected DOT tire identification numbers. All tires found to have an affected DOT identification number will be replaced and will be scrapped according to applicable law. Consumers who have had their tires replaced before this recall may be eligible to receive reimbursement for the cost of obtaining a pre-notification remedy of the problem associated with this recall.
	In accordance with the provisions of 49 C.F.R. § 573.6(c) (9) (i), Cooper Tire & Rubber Company will make dealers aware of the legal requirements associated with the prohibition against the sale of recalled tires through a Dealer Notification Letter that will be submitted to the agency separately pursuant to 49 C.F.R. § 573.6(c) (10). The program for disposing of all recalled tires returned to Cooper Tire & Rubber Company will comply with applicable state and local laws and regulations regarding the disposal of tires, and to the extent possible, tires will be channeled into a category of positive reuse or another alternative beneficial non-vehicular reuse, instead of being disposed of in landfills.
How Remedy Component Differs from Recalled Component :	The remedy components will be equivalent tires built with the new process and specifications.
