#### **Chronology**:

On June 18, 2021, Hankook Tire received notice that three tires had been returned. Two of those tires had a bulge in the tread area. Hankook Tire received the tires for testing on June 21, 2020, and began an investigation into the issue.

From June 21 to July 9, Hankook Tire performed tests and investigated the issue with these tires. Hankook Tire determined that the tires were made with a batch of rubber in the sub-tread area that had an insufficient amount of curative agent. Hankook Tire then determined the barcode numbers for tires made with that same batch of rubber. After tracing the barcode numbers and inventory, Hankook Tire determined that 172 of these tires had been shipped out and not returned.

On July 9, Hankook Tire's Product Safety Committee determined to recall these tires based on a safety defect. Hankook Tire received notice of one additional tire returned with this issue on July 14. Hankook Tire is not

aware of any injuries due to this defect. **Description of Remedy :** Description of Remedy Program : Hankook Tire and General Motors will conduct a safety recall campaign to replace the affected tires that have been sold as original equipment tires. Because Hankook Tire was able to identify the 172 tires by barcode, Hankook Tire will replace tires by DOT and barcode number, but not limited to the barcode, depending on the condition of the barcode and/or tire. All known distributors, dealers, and independent outlets will receive notification of the campaign, instructions on how to identify the affected tires, corresponding DOT numbers and barcode numbers, information regarding removal of the affected tires from service, and instruction on the return/disposal of affected tires. All potentially affected tires were sent to GM for installation on new vehicles. Therefore, the owners will receive notifications from GM as part of GM's separate recall, 21V-612. Hankook Tire will not be issuing separate owner notification letters. Hankook Tire will offer to reimburse the replacement cost for any customer who, prior to this campaign, replaced these tires due to the condition described above. How Remedy Component Differs The remedy tires will be offered from barcode numbers that are not from Recalled Component : affected by the production condition described above.
