Description of the Defect : The microwave circuits are run with 14/2 wire and connected to a 20 amp circuit breaker instead of a 15 amp circuit breaker.

**Chronology :**

1/12/2021 - RVIA performed a code inspection of Plant 4 and found the 14/2 wired microwave circuit is incorrectly protected with a 20 amp circuit breaker. All product from Plant 4 in the yard is placed on hold.

1/13/2021 - All units in the yard are inspected and found to have the same issue. These units have the circuit breakers changed to 15 amp circuit breakers.

1/14/2021 - Investigation finds a change in the wiring occurred in October 2020.

1/15/2021 - A safety committee review determines that a recall should be issued.

## Description of Remedy :

Description of Remedy Program : Replace the 20 amp circuit breaker with a 15 amp circuit breaker.

How Remedy Component Differs from Recalled Component : NR
