Description of the Defect : Recall 20E71, Dometic Corporation has identified the Model 1731 Ovens and Stoves have a potential defect. A gas leak may occur at the joint between the gas saddle valve for the burners and the manifold connection.

FMVSS 1 : 302 - Flammability of interior materials

FMVSS 2 : NR

Description of the Safety Risk : There is a risk of a gas leak which may cause an explosion and or fire.

Description of the Cause : Dometic believes these leaks are caused by field adjustments when overtightening a securement bolt for the saddle valve to the manifold

Dometic handled and identified all initial investigations and testing to determine the recall/ defect of their product.

- Bigfoot RV closed for annual winter shutdown Dec 24, 2020 - Jan 3, 2021
- Jan 3 2021 – returning from winter shutdown received recall notification letter from Dometic
- Jan 7, 2021 – dealers notified of the recall via email, stating we are looking into affected units
- Jan 7, 2021 – March 15, 2021 – internal review of unit folders to determine which units were affected in the provided date range and oven serial number sequence
- Feb 19, 2021 – draft owner/ customer letter submitted to recall portal
- March 18, 2021 – owner/ customer notification letter sent out via mail
- Recall remedies/ warranties are completed by Dometic. Dates recalls completed so far include:
 - o April 19, 2021 – first recall remedied for 21V-047
 - o Remedies to continue by Dometic and dates to be added as we receive reports.

No warranty claims or field/ service reports reported to Bigfoot prior to the recall.
