Chronology:

On December 10, 2020, a potential issue involving sunroof operation was raised during an analysis and test program. A review of software / coding suggested that certain aspects of the software, specifically for sunroof operation of the US market version of the 2 Series Gran Coupe, may not be appropriate.

An engineering review was initiated. Further testing was performed, and a review and comparison of worldwide regulatory requirements, including FMVSS 118, was performed.

In January 2021, the review indicated that during 2 Series Gran Coupe vehicle development, FMVSS 118 certification and testing had been performed and was successful. Further review indicated however, that prior to engineering release and vehicle production, sunroof operation software / coding for the ECE market had inadvertently been implemented into US vehicle production for this specific vehicle model.

On February 10, 2021, BMW decided to conduct a voluntary non-compliance recall.

BMW has not received any reports, nor is BMW otherwise aware, of any accidents or injuries related to this issue.

Description of Remedy:

Description of Remedy Program: The electronic coding for sunroof operation will be reprogrammed.

Owners will be notified by First Class mail and instructed to take their vehicle to an authorized BMW center to have the remedy performed for free. If this condition was noticed on a potentially affected vehicle prior to this recall, the remedy would be covered by the BMW New Vehicle Limited Warranty program. Therefore, reimbursement for a pre-notification

remedy re Part 573.13 and Part 577.11 is not necessary.
