Description of the Safety Risk: Affected vehicles that have the auxiliary lock on the sliding door that is not

compatible with the electric sliding door variant, may show an increased outward dislocation of the sliding door in case of a crash, therefore, they do not comply with FMVSS 226 and could increase the risk of injuries in case of a

crash.

## **Chronology:**

In late September 2020, based on internal review of the technical documentation, MBAG became aware of a potential issue concerning the auxiliary lock on the sliding door installed on certain Sprinter platform 907 vehicles. MBAG found that for certain vehicle configurations equipped with the electric sliding door option, the technical documentation showed an auxiliary lock that is not compatible with an electric sliding door. MBAG commenced its investigation to understand how vehicles from the concerned configuration had been built until that date.

In parallel, also in September 2020, any vehicles from the affected configuration that were still located at the production plant were blocked, and if needed, the electric sliding door was replaced by a mechanical sliding door. The affected configuration was also blocked for further sale and production until the matter could be resolved.

Through its ongoing investigation, which lasted into the fourth quarter of 2020, MBAG found that workers in the plant had identified that the auxiliary locks referenced in the technical documentation physically did not fit into the affected vehicles. However, the standard escalation process was not triggered as it should have been and the locks were instead replaced with a different lock from another load carrier that was located nearby at the assembly line. Although this lock physically fit into the vehicles, it was specified only for the vehicles with manual sliding door mechanism.

MBAG commenced its analysis as to the potential consequences of the incorrect lock mounted to affected vehicles with electric sliding door. Including the consideration of results from specific tests, the analysis lasted into early 2021 and upon further review of the FMVSS 226 requirements, on March 3, 2021, MBAG determined

a noncompliance existed in the vehicles.
