On February 19, 2021, Ford's Critical Concern Review Group (CCRG) was informed of an issue regarding a Continental Tire the Americas (CTA) tire durability concern. CTA notified Ford that it had shipped nineteen potentially over cured tires to four Ford Assembly Plants between 2018 and 2020. CTA filed a defect notice with NHTSA (21T-001) on February 15, 2021 identifying ten affected OEMs including Ford. Ford utilized CTA's

Ford is not aware of any reports of accident or injury related to this condition.

#### **Description of Remedy :**

Description of Remedy Program :	Owners will be notified by mail and instructed to take their vehicle to a Ford or Lincoln dealer to have their tires inspected for the suspect DOT and production mold numbers. If a tire's DOT and production mold numbers match the suspect tire list provided by CTA, the dealer will replace the suspect tire. On vehicles that have been sold, the dealer will also replace the corresponding tire on the opposite side of the axle. If a pair of tires are replaced, the new tires will be installed/moved to the rear axle locations. There will be no charge for this service. Ford is excluding reimbursement for costs because the original warranty program would provide for a free repair for this concern. Ford will forward a copy of the notification letters to dealers to the agency when available.
