- July 9, 2020 -after some period of usage, occupant may smell gas near the stove when it is not in operation. If the user or other servicer than attempts to tighten the bolts that hold the valves under the stove burners, the tightening action can cause irreversible damage to the o-ring seal at the valve (s),

10-1-2020 Thor released information to Jayco that Dometic was filing a safety recall on model S31 R1731 and R2131 cooking stoves. Jayco waited for official notice with listing of stove sold to any of Jayco divisions - While we could see information filed on NHTSA portal. JAYCO COMPLIANCE DID NOT RECEIVE OFFICIAL RECALL NOTICE from Dometic. Jayco Compliance reached out to Dometic for list of the recall stoves (if any) sold to any Jayco Division - multiple times from Nov 2020 through March 5, 2021 when Jayco requested a formal letter stating none of the recalled stoves were sold to any Jayco division so we could close the incident.. March 11.2021 Jayco Compliance receive an email from Dometic noting 1,000 recalled stove serial numbers sold to the Highland Ridge Division of Jayco. Jayco is currently matching the stove serial numbers to HIGHLAND RIDGE PRODUCTS.
