Chronology :

On February 25, 2021, Forest River's Office of Corporate Compliance ("OCC") was notified by the supplier, Lippert Components ("LCI") that a 10,000 lbs. rated fifth-wheel pin box was used in certain applications which did not meet the Gross Vehicle Weight Rating ("GVWR") of the vehicle. It was understood that all vehicles' pin box were changed to a 16,000 lbs. GVWR rated pin box in production and before any vehicles shipped. LCI was to supply OCC and the manufacturing plant with a VIN listing of vehicles that had been corrected. OCC opened an investigation into the concern.

On March 17, 2021, OCC asked LCI for an update of the VINs and if any vehicles may have left the manufacturing plant.

On March 18, 2021, LCI provided four vehicle numbers in which their service team identified as having the incorrect pin box and had been corrected prior to shipment from the manufacturing plant. LCI indicated that they would supply a list of potential vehicles that may have shipped; however, OCC and the manufacturing plant were not aware of any vehicles that shipped with the incorrect pin box.

On March 30, 2021, OCC received a shipment history, which is tied to purchase orders from the manufacturing plant. OCC began reviewing manufacturing records.

On April 2, 2021, Forest River's Corporate Recall Committee voted to recall.
